B. Verbal report from Parks and Recreation Director, Roger Hall, on maintenance issues and playability at the Municipal Golf Course

Parks and Recreation Manager, Julie Calloway, discussed maintenance and playability at the Municipal Golf Course. She stated that Turf Tech has been doing their routine maintenance of fertilizing, aeration, edging around the bunkers, and trimming low branches as needed. In addition, Turf Tech top-dressed and dragged the entire range to fill in divots from the extensive wintertime use. Manager Calloway stated that upcoming projects include the continuation of tree trimming and to finish edging sand traps.

B. Verbal report from Recreation Coordinator, Jennifer Spinkelink, on the status of special interest classes, special events, youth center, and art center

Recreation Coordinator, Jennifer Spinkelink, discussed the status of special interest classes, tiny tots, and the art center. She stated that the tiny tot graduation was a success as well as the year-end party at the Splash Park. She also said that the first two months of tiny tot summer camp is full. Coordinator Spinkelink, explained because of staffing challenges for safekey, the summer program will have a limited class size of twenty kids a day. In addition, Coordinator Spinkelink shared that all classes are opened and are filling up quickly. She stated the pottery classes has more students than in recent times. Vice-Chairman, Carla Morgan, praised the tiny tot program and the year-end party.

C. Verbal report from Recreation Sports Coordinator, Kelly Lehr, on the status of youth and adult sports

Recreation Sports Coordinator, Kelly Lehr, discussed status of youth and adult sports. She reported that the State approved kindergarten, first and second grade hockey for January-March. They were able to have an outside league for hockey and followed all CDC guidelines. Coordinator Lehr stated they were approved by the Department of Business and Industry for t-ball, coach pitch and baseball. She stated that the State also approved adult sports which included an over the line tournament and an adult co-ed softball league. Coordinator Lehr stated that pickle ball has been operating in the new gym Monday thru Saturday and open gym has re-opened. She explained no masks were required if fully vaccinated. In-addition, Coordinator Lehr said rentals for the fields and gyms have increased. She stated Covid has been challenging, but said the staff is doing a great job and she encouraged the committee members to come out and watch.

D. Verbal report from Parks and Recreation Manager, Julie Calloway, on the status of Parks and Recreation Administration

Manager, Julie Calloway handed out the Special Events Master List and discussed the status of Parks and Recreation Administration. She stated that Parks and Recreation is in the process of finalizing the current fiscal year and beginning prep for fiscal year 2022. She explained that upcoming Capital Improvement Projects include golf course improvements and general park improvements. In addition, Manager Calloway stated that the Hemenway expansion is about halfway through completion and includes a walking path and benches along the trail. She also said there has been minimal damage to the natural habitat. Manager Calloway said the Parks and Recreation building will re-open to the public on June 1st. Manager Calloway stated she is meeting with a company later this week about possibly adding outdoor pickleball courts at Hemenway Park and Broadbent Park. She also stated that the Turf Tech's golf maintenance contract is on the City Council agenda at the May 25, 2021 meeting for possible approval and Cascata golf day is scheduled for September 1st. The save the date notice will go out next week and registration will be in July.

B. Verbal report from Aquatic Coordinator Cheree Brennan on classes, special events, and maintenance issues at the swim pool complex.

Aquatic Coordinator, Cheree Brennan, discussed classes and special events at the swim pool complex. Coordinator Brennan stated that class sizes will be increasing, and reservations are still required at this time. She reported the Bubble was taken down on Wednesday, May 19th. Currently the pool is closed and will reopen Memorial Day. Coordinator Brennan stated they will have five water aerobics classes, a new Jr. Lifeguard program, and adult and youth synchronized swimming this summer. She also shared that the pool has been rented several times by outside groups for training and Little Lambs is interested in visiting the pool three time a week this summer. Coordinator Brennan said swimming lessons are starting to increase. She said staffing has been an issue and swimming instructors are needed. Member Pickens asked if the chlorine shortage affected them at all. Coordinator Brennan stated it was not an issue.

C. Verbal report from Parks and Recreation Director, Roger Hall, regarding the Municipal Ad Hoc Pool Committee

Manager Calloway stated that the Ad Hoc Pool Committee's final meeting was in March and their recommendation was to proceed with a new pool facility based on the report of the contractor. She stated the next step will be the Community voting on the ballot questions. Vice-Chairman Morgan asked about the design. Manager Calloway stated it was based on a conceptual design. She explained that the pool design and basic elements are available on the City's website bcnv.org.

5. For possible action: Verbal report from Director Roger Hall on mountain biking and the aerial trail system in Bootleg Canyon

Manager Calloway discussed events at Bootleg Canyon and said races are still going strong. She said the aerial trail system is closed but the owner of Flightlinez plans on coming back in fall. Member Pickens asked if Flightlinez secured the lines before they closed, and Manager Calloway said yes.

Manager Calloway asked for direction regarding possibly cancelling the July 26, 2021 meeting due to construction that will be taking place during that time in council chambers. Classes

*The only classes held in May were Water Fitness and PreSwim, due to Bubble Up/seasonal maintenance. **May** registrations: PreSwim: **7**; 9 am Aqua Fit: **15**; 12:15 pm Aqua Fit: **15**; 7 am Total Water: **12**; 8 am Total Water: **16**.

*Class size was still limited in May but beginning in June we were able to increase the number of students allowed, depending on class type.

Events

*May was National Water Safety Month-an article was written for the Boulder City Review, and educational materials and activity books were available at the swimming pool.

*The World's Largest Swimming Lesson was held June 17th, with 80 students in attendance (including King Elem. and Safe Key), 14 lifeguards/other staff on duty, and 12 volunteers.

*July 3: Coin Toss!! 11 am 352 total people, to include Coin Toss participants, spectators, and those who came for Open Swim

Programming Notes

- *Held Water Safety Instructor course in May, resulting in 1 new WSI for Boulder City.
- *BCH Club Swim held practice 5x/week with an average of **36** swimmers on their roster each month.
- *HM Safety Certifications continues to rent the facility for their Lifeguard Training course, with **4 uses** during May-Aug. with an average of **6 students per time**.
- *The U.S. Bureau of Reclamation rented the dive tank and a small portion of the main pool in June for their annual Dive Team training-**13 individuals** in attendance.
- *Little Lambs from the Christ Lutheran Church held some of their day camp activities at the Pool & Racquetball Complex, attending open swim 3x/week and utilizing a racquetball court 2x/week for games and skill development-an average of 25 youth and 3 adults each day.
- *King Elementary brought their summer enrichment students to open swim at the pool in June 1x/week, with an average of **54 students** and **9 adults** each week.
- *Garret Junior High brought 27 students and 3 teachers on July 30 for open swim.
- *Jack & the Beanstalk Day Care and Christian Center also utilized the swimming pool a number of times over the summer, accounting for an average of **7 youth** and **3 adults** each week in June and July.

- *Lifeguarding course held in June, resulting in 3 new lifeguards for Boulder City.
- *The new Junior Lifeguarding program ran June-July. Participants ranged in age from 12 to 15. For our first year, it went very well. There were **11 participants**, 8 in June and 3 in July. All but 2 (1 incomplete, 1 fail) fully completed the American Red Cross Junior Lifeguard course and Adult & Pediatric CPR/AED/First Aid certification. Unfortunately, none of them are old enough to employ. During the session, they were able to assist with swim lessons, shadow Lifeguards, learn all the skills that Lifeguards do, and participate in some team building activities.

-Next year, we would like to train some other staff members to help with the program (must be WSI or LGI certified). We would also like to develop a more strategic outline for each session that goes along with the Red Cross outline but also fits with our facility. It would also be ideal to have smaller groups, consisting of only 4 -6 youth per session, which would enable them to have more one on one time and allow them to shadow Lifeguards and WSIs more easily.

Maintenance

- *Hot water heater for showers went out May 27; repaired June 10 (parts took a while to receive)
- *Liquid chlorine tubing replaced June 21
- *Pool heater serviced Aug. 12
- *Chlorine feeders have had a few pieces replaced over the summer due to the corrosive nature of chlorinethe Building Maintenance plumber has been able to take care of the repairs.
- *We have been backwashing ourselves (no outside contractor), with help from the Bldg. Maintenance plumber. We do close the pool for this but do it at the least impactful time during the week. So far, no patron complaints!

June 29: 11am-3pm Aug. 26: 9am-3pm

- *An audit was performed by Aquatic Safety Research group on June 17th, at the request of POOL/PACT-we received a nice report with only a few items identified as "medium" risk that we are attending to
- *Aug 17 & 24 SNHD conducted its inspection, with a few different items that need to be corrected
 - --We are working on these items in conjunction with Public Works

Administration

- *We still do not have a Pool Maintenance Worker as there have not been any qualified applicants. We are brainstorming for solutions...
- *Even though we hired 8 new lifeguards, many left our employment due to college/other before the end of July; we currently have an inadequate number of lifeguards and have had to continuously adjust our hours and programming.

Projects

- *May: Pit thoroughly cleaned May 18; main pool acid washed May 20
- *We are now getting ready for Bubble UP! Bubble Up day is September 29th. The pool will be closed Sept.
- 24- Oct. 11; Office and Court hours during this time will be Mon/Tu/Th 3-7 pm & Wed 1-4 pm.
- *During the pool closure the following projects will take place:
 - -The remainder of the old filter grids will be replaced
 - -Old/out of use lighting will be removed from mechanical room
 - -Many deck anchors for the winter covers will be replaced
 - -Several black tiles from main pool need to be replaced

Closures

- *June 24: lighting 1-3 pm
- *July 22 lightning 3:15-5:45 pm
- *Aug. 16 only main pool open due to leaking gasket above pump #1 and needing to shut it down (can only operate one pool when only one pump is in operation)
- *Aug. 19: No Family Hour and only main pool for Open Swim due to insufficient number of lifeguards
